## Şafe at Schools Public Act 12 of 2016

- \*Scheduling of Drills-Required by September 15<sup>th</sup> of each school year. (Due to LCPS admin by Sept 5)
- \*MUST complete drills on the date and time as committed-change only due to conditions beyond the control of school authorities (severe storms, fires, epidemics, power failure, water/sewer failure, health condition, as defined by county or state health authorities. If cancelled, must be rescheduled to occur within 10 school days after the originally scheduled date of the cancelled drill.

\*Documentation of a completed drill MUST be posted on website within 30 days after the drill is complete and maintained on the website for at least 3 years. (Documentation must include: a) name of the school, b) school year of the drill, c) date and time of drill, d) type of drill completed, e) Number of completed drills for that year for each type of drill required, f) the signature of the school principal/designee acknowledging the drill, g)the name of the individual in charge of conducting the drill, if other than the principal.

## Fire Drills

- Minimum of 5 drills per year
  - Three must be held by Dec 1<sup>st</sup>
  - Two shall be held during the remainder of the year with a reasonable spacing interval between each drill

  - o At least one must be conducted during the month of March

## **Lockdown Drills**

- Minimum of 3 drills per year
  - At least one must be held by December 1<sup>st</sup>
  - At least one must be held after January 1<sup>st</sup>, with a reasonable spacing interval between each drill
  - Must include security measures appropriate to an emergency such as:
    - -release of hazardous materials
    - presence of a potentially dangerous individual on or near the premises
