

### 2025-2026 <u>LIMITED External</u> Schools of Choice Guidelines HIGH SCHOOL

Limited Grades 9 & 10 (40 seats total) May 1 – May 30, 2025 Criteria Based Admission, i.e. MST Program
Grade 10 (10 seats) Grade 11 (10 seats)
May 1 – 30, 2025

Applications must be received by 3:00 p.m. on May 30, 2025

- 1. Must be a resident of Macomb County.
- 2. Applications will only be accepted during the above approved dates.
- 3. Siblings of students who are currently enrolled in L'Anse Creuse through schools of choice will be given priority to attend, based on available space.
- 4. Once students are accepted, they can remain in L'Anse Creuse until they graduate.
- 5. Applicant students who have been suspended or ever expelled within the last 2 years will be excluded.
- 6. Transportation is the responsibility of the family. All students will need transportation no later than 15 minutes beyond the end of the school day.

#### ITEMS TO BE SUBMITTED

All items that apply MUST be submitted with the application. Incomplete packets will not be accepted.

 If parent's name is not on the lease, must have a completed Statement of Landlord signed by apartment manager with parent and student name listed.
